Method of Accounting: -

The Company has adopted Indian Accounting Standards (IND AS) from the financial year ending 31st March, 2019. IND AS 116 on Accounting on Lease came into effect on 01st April, 2019. Accordingly, Company has adopted IND AS 116 and applied the standard to Long term Lease contract existing on 01st April 2020.

Capital Adequacy: -

The Regulator i.e. Pension Fund Regulatory & Development Authority (PFRDA) has not prescribed any Capital Adequacy Ratio for the Pension Fund Industry. However, PFRDA vide PFRDA (Pension Fund) (Second Amendment) Regulations, 2020 dated 04th February, 2020 requires the Pension Fund to achieve minimum tangible net worth of Rs. Fifty crore (50) crores or such higher amount. Your Company is in compliance with the net worth requirement. As on 31st March 2023, the net worth of your Company is Rs. 149.59 crores.

Share Capital: -

The Authorized Share capital of your Company stood at Rs. 100 (Hundred) crores as on 31st March 2023. The issued, subscribed and paid-up share capital of your Company stood at Rs. Thirty (30) crores comprising of Three (3) crores equity shares of Rs. 10/- each fully paid.

During the financial year under review, your Company had not issued any equity/ preference shares or any securities which carry a right or option to convert such securities into shares, equity shares with differential rights, sweat equity shares, warrants, debentures, bonds or any non-convertible securities or employee stock options.

There was no reduction of share capital or buyback of shares, change in the capital structure resulting from restructuring, change in voting rights or re-classification or sub-division of the authorized share capital.

Subsidiaries, Associates and Joint Venture Companies: -

Your Company continues to be a Subsidiary Company of State Bank of India. Your Company does not have any Subsidiaries, Associate or Joint Venture Companies.



Dividend: -

Your Company has posted a Profit After Tax of Rs. 5,350.56 Lakhs for the financial year ended 31st March 2023. To conserve the profit for future business requirements, the Directors of your Company do not propose any dividend for F.Y. 2022-23.

Amount to be carried forward to Reserves: -

The Board of Directors of your Company has decided not to transfer any amount to the Reserves for the year under review. The Company proposed to retain the whole amount in the Profit & Loss Account.

Change in the nature of Business, if any: -

During the year under review, there was no change in the nature of business of your Company.

Economic Environment: -

Global Economy

Global growth in CY22 at 3.2% came below expectation largely impacted by Ukraine war and slowdown in China. Central Banks faced a difficult task of taming inflation via higher interest rates without triggering a recession. Headline inflation is now seen declining, but core inflation remains elevated, held up by strong service price increases, higher margins in some sectors and cost pressures from tight labor markets. Post Silicon Valley Bank and Signature Bank collapse resulted in credit tightening which eased the pressure on Fed for further rate hike. The Federal Reserve had series of rate hikes including 25 bps in March 2023 raising the Fed funds rate to a range of 4.75% to 5%.

US economy in CY22 reported growth of 2.1% y-o-y as compared to 5.9% y-o-y in the previous year. Euro Zone slipped to 3.5% y-o-y in CY22 from high growth of 5.3% in CY21 after making come back from Covid induced slowdown. China's stringent zero covid policy impacted the business activity across the country reducing its growth from 8.4% in CY21 to 3% in CY22.

Brent declined by 26.1% in FY23 anticipating a fall in demand due to overall expected slowdown, closing at USD 79.77 as on 31.03.2023 from USD 107.91 as on 31.03.2022. The Bloomberg commodity Index fell in line with brent by 15.2% in FY23. The US dollar index strengthened from 98.31 as on 31.03.2022 to 102.51 as on 31.03.2023.



Domestic Economy

Growth

India's real GDP growth for Q4 FY23 at 6.1% was ahead of market expectation compared to 4.5% in Q3 FY23. Strong growth in the last quarter was driven by strongest sequential investment growth and government spending, however consumption was a drag. For full year FY23 GDP is estimated at 7.2%, higher than NSO's advance estimates of 7%. The upward revision is led by Q4 GDP growth coming in far stronger than earlier estimated. For FY23, on the production side, industry led to moderation in the overall GVA growth, even as the performance of agriculture, forestry and fishing and services improved relative to FY22. The nominal GDP for FY23 has been pegged at Rs. 272.4 trillion as per the Provisional Estimates, growing at a nominal rate of 16.1%.

Inflation

Inflation in the entire FY23 remained above the MPC threshold. CPI declined from 6.95% in March 2022 to 5.66% in March 2023. The decline was driven by the food and miscellaneous category offset by an increase in housing and fuel prices. Core CPI continued to remain elevated at 5.95% in March 2023, down from 6.53% in March 2022. High Household coupled with increase in services like Education and Personal care contributed to high core inflation. Average Retail CPI and Core inflation for FY23 (Apr 2022 - Mar 2023) stood at 6.66% and 6.30%, respectively. Cooling of input prices on the back of fall in commodity prices contributed to WPI inflation declining to 1.34% in March 2023 from 14.63% in March 2022. Average WPI inflation for FY23 (Apr 2022 - Mar 2023) stood at 9.59%.

Fiscal Deficit

The central government managed to achieve a 6.4% fiscal deficit target for FY23 down from 6.7% in the last financial year. The government was aided by buoyant tax receipts and some fiscal headroom due to lower food and fertilizer subsidy bills. Higher dividends by central public sector enterprises offset the shortfall in disinvestment revenue for FY23. The government in its FY24 union budget prioritized fiscal consolidation with focus on capital expenditure to achieve higher medium-term GDP growth. It has a targeted central fiscal deficit of 5.9% in FY24BE, staying on course to reach the targeted 4.5% by FY26.

External Sector

India's current account deficit (CAD) for Q3FY23 at USD 18.2 billion (2.2% of GDP), significantly lower on sequential basis from the USD 30.9 billion (3.7% of GDP) in Q2FY23. The lower CAD can be attributed to the narrowing of the merchandise trade deficit, which decreased to USD 72.7 billion in Q3FY23 coupled with robust services and private transfer receipts. CAD for 9MFY23 reported at USD 67.1 billion (2.7% of the GDP). For the nine months ended Dec 2022, depletion to foreign exchange reserves (on Balance of Payment basis) was USD 14.7 billion. Capital account balance for 9MFY23 was supported by banking capital despite lower portfolio flows compared previous year.



Outlook

As per OECD, Global growth is projected to remain at below trend rates in CY23 and CY24, at 2.6% and 2.9% respectively, with policy tightening continuing to take effect. Inflation is projected to moderate gradually over CY23 and CY24 but to remain above central bank objectives until the latter half of CY24 in most countries. The improvement in the outlook is still fragile. Risks have become somewhat better balanced but remain tilted to the downside. Uncertainty about the course of the war in Ukraine and its broader consequences is a key concern. The strength of the impact from monetary policy changes is difficult to gauge and could continue to expose financial vulnerabilities from high debt and stretched asset valuations, and also in specific financial market segments. Pressures in global energy markets could also reappear, leading to renewed price spikes and higher inflation¹.

Domestically, despite global slowdown concerns, the Monetary Policy Committee (MPC), revised its real GDP growth for FY24 to 6.5% in March 2023 bi-monthly monetary policy. The upward revision of 10 bps in Growth was based on strengthening rural demand from good rabi production, and support to manufacturing and investment activity from the central government's focus on capital expenditure, improving capacity utilization, robust credit growth, and moderation in commodity prices. Additionally, MPC revised the FY24 average inflation down by 10 bps to 5.2% considering good rabi production and easing cost, which is expected to moderate the pace of output price increases.

MPC in March 2023, kept the repo rate unchanged at 6.50% and maintained the policy stance as 'withdrawal of accommodation' emphasizing on the fact that MPC is open to rate hike in future if the situations warrant for such event. This was contrary to the consensus market expectation of a rate hike of 25 bps. Hence, benchmark G-sec yields moved down by 10 bps while 5 bps movement was seen in medium duration and long duration after the policy. RBI remains comfortable on the growth front, for now, though risks to the outlook will be from the external sources. We expect longer pause by RBI post reaching to peak of the rate hike cycle. FY24 is expected to be a year of accruals with some element of mark to market gains in the later part of the financial year.

H1FY24 borrowing calendar shows that the government will borrow Rs 8.8 trillion through weekly G-sec auctions. This accounts for ~58% of the total borrowing. Further, the proportion of the longer duration bonds in the auction has been increased to ~33% of the total issue. A higher supply of bonds each week may put pressure on the long end of the yield curve with 10 year benchmark creating floor at ~7.0%

FY23 was a challenging year for the Indian equity markets. While the market had to navigate continued global macro headwinds such as rising inflation and volatile crude oil prices, fresh set of concerns came in the form of collapse of Silicon Valley Bank in US leading to run on regional rural banks and contagion fear from Credit Suisse bankruptcy

leading to its abrupt merger with the larger Swiss rival UBS Bank. Further uncertainty around Adani credit crisis led to carnage in Adani Group names and had a domino impact on India financials sector with continued FII selling, souring the market sentiments. FIIs for FY23 witnessed selling of USD 5.1 billion.

Nifty declined by 0.6% in FY23. Indian market underperformed the developed markets in Europe. US market and MSCI emerging market index underperformed India. Banking, Capital Goods, FMCG, IT and Autos were the clear outperforming sectors for the year while all other sectors including Information Technology underperformed for the FY23.

While currently Nifty Index is trading at 18x on FY24E- which is in line with its long-term average, there are fears of downgrades in earnings given growth in financial sector which comprises 60% of the Nifty index earnings is likely to witness compression in NIMs due to continued rise on deposit rates. Additionally, volatility in Brent oil prices impact nearly 35% of the Nifty earnings, which remains another key risk to Nifty earnings.

On overall basis, we continue to adopt bottoms up approach in identifying high quality companies available at reasonable valuations while at the same time remaining positive on a) Financials given asset quality holding up b) domestic economy driven sectors where consumption continues such as Autos, Infrastructure and Capital Goods.


Review of Business Performance and State of the Company's Affairs

Your Company's mission is to provide credible, professional and customer focused Pension Fund management and POP Business solutions.

The performance of your Company during the financial year 2022-23 in respect of various business activities are as under:

- 1) Fund Management Activity
- During the year under review, your Company closed the fiscal with AUM of Rs. 3,39,006 crores representing a growth of 20% over the previous fiscal, to retain lead position amongst Pension Fund Managers (10 Nos) in terms of market share, 34.52% of total AUM for the Government Sector and 48.83% of total AUM for the Private Sector with overall Market Share of 37.71%.
- During the year under review, your Company outperformed the benchmark for Scheme CG, Scheme SG, Scheme Corporate CG, Scheme NPS Lite and Scheme Atal Pension Yojana.





• The details of Asset Under Management (AUM) growth of the Company:

 As per the PFRDA guidelines on Common Stewardship Code, your Company has in place a Comprehensive policy to protect the subscribers' interest. The policy broadly covers managing the conflict of interest, monitoring the investee companies, active intervention/engagement with the investee companies, clear policy on voting and periodically reporting of the same to the regulator.

Business Strategy and Outlook:

During the year, the fresh inflows of Rs. 32,090 crores coupled with accruals and net of appreciation on account of market valuation took the total AUM under Government Sector NPS to Rs. 2,40,880 crores with a market share of 34.52% (Rs. 6,97,743 crores). Under the Private Sector NPS (including NPS Lite), the fresh inflows of Rs. 20,620 crores and net of appreciation took the AUM to Rs 98,125 crores with a market share of 48.79% (Rs. 2,01,120 crores). Overall, your company has recorded a growth of 20.01% in its AUM during the year, which increased from Rs. 2,82,476 crores to Rs 3,39,006 crores. Overall market share of your Company remained at 37.71%.

2) **POP Activity**

The company has been functioning as a POP since 2019 after receiving the license from the regulator. POP onboards new subscribers under the "All Citizen Model" and new subscribers and corporates under the "Corporate Sector Model". POP also conducts awareness sessions for NPS subscribers and services the NPS accounts of the associated subscribers.

- 1. Partnership with annuity team of SBI Life to promote NPS to Central & State Government subscribers.
- 2. Participating in all the synergy meets scheduled by SBI for its subsidiaries to increase awareness of NPS and schedule joint meetings with the Corporates associated with SBI & other subsidiary companies.
- 3. Engaging with CAG, CCG and SME branches of SBI to reach out to the Corporates for bringing them under ambit of Corporate NPS.

- 4. NPS awareness sessions for corporates are held regularly to educate the decision makers and employees to have better understanding of NPS and its benefits. Corporate Support in following areas is being offered to facilitate corporate onboarding:
 - a. Support to CPSEs/corporates to increase product awareness about NPS benefits over existing Superannuation Fund (SAF) scheme.
 - b. Switching over from Superannuation Funds to NPS
 - c. Documentation support for closure of existing superannuation schemes, if desired by the corporates.
 - d. HR Department Handholding to support them during NPS implementation for the employees.
 - e. Employee engagement programs to emphasize the importance of choosing the right PFM and how allocation of funds.
 - f. Cost benefits to the corporate while dealing with SBIPFPL as POP and as a PFM
 - g. Special handholding for Nodal Officers across different geographies.
 - h. Organizing webinars for different offices/locations as per the requirement of the corporate.
- 5. Branches at various locations are opened to increase overall business. 15 Branch setup has been done. Recruitment and operationalization of a few branches is in completion mode as on 31.03.2023.
- 6. Social media team is being set up to increase visibility of NPS on the digital front and provide an alterative mode of distribution to onboard new subscribers.
- 7. Various distribution models (Business correspondent/POP SE etc.) are explored to offer NPS to more customers across various geographies.

Risk Management: -

In terms of the provisions of Section 134 (3) (n) of the Companies Act, 2013 and also in compliance with Pension Fund Regulatory and Development Authority (Pension Fund) Regulations, 2015 (including amendments thereof), the Company is having a proper risk management framework in place for identification, measurement, management, control and mitigation of various risks inherent in Company's business and various NPS schemes managed by the Company.

As per the Investment Management Agreement entered by the Company with NPS Trust, a comprehensive Board approved Risk Management Policy aligned with the SBI Group Risk Management Policy is in place which is reviewed and duly approved by the Risk Management Committee of the Board and the Board of Directors at half-yearly intervals. The Risk Management Policy covers Credit & Investment Risk, Operational Risk, Market

Risk, Liquidity Risk, Reputation Risk and other risks which includes compliance, contagion, counterparty, Information Technology and strategic risk etc. Key risk indicators have been defined for risk measurement which are duly monitored. We have adopted Risk Control Self-Assessment (RCSA) methodology to identify organization wide risks which is duly escalated to the Risk Management Committee of the Board.

Risk profiling of the various scheme of NPS has been introduced by PFRDA to disclose on risk involved in various scheme of NPS for awareness of the subscribers, therefore, pension funds are required to disclose risk-profile of the NPS schemes at quarterly intervals.

The Company has in place Information Technology Policy, Information Security Policy and Cyber Security policy to implement security measures for preserving the security of data and technology infrastructure which is approved by the Board of the Company. The IT team works towards managing the confidentiality, integrity and availability of data across organization process covering all the employees, contractors, and anyone who has permanent or temporary access to the systems & hardware and securing all the applications and systems on an ongoing basis.

Cyber security awareness and training to all employees are provided through various initiatives such as advisories issued by the IT team, conducting Risk Awareness programme etc.

The Risk Management Committee of the Board and Board of Directors periodically reviews the Risk Management Policy, procedures & process and functions of the Company. It also reviews the performance of various schemes managed by the Company at quarterly intervals.

REPORT ON THE AUDIT OF THE STANDALONE IND AS FINANCIAL STATEMENTS OPINION

1. Notes to the financial statements for the Year ended 31st March 2023

Company's Basic Information-

SBI Pension Funds Private Limited is a Private Limited company incorporated on 14th December 2007. It is classified as Union Government Company and is registered at Registrar of Companies, Mumbai. SBI Pension Funds Private Limited's Corporate Identification Number is (CIN) U66020MH2007GOI176787, its registration number is 176787 and its registered office address is 1904 19th Floor, B Wing Parinee Crescenzo, Bandra Kurla Complex, Bandra Mumbai 400051. The company acts as Pension Fund Manager of the corpus owned by NPS Trust and also as Point of Presence (POP) under NPS Architecture.

Note 1: - Significant Accounting Policies

a. Basis of Preparation of financial statements (Ind AS - 1)

These financial statements have been prepared in accordance with Indian Accounting Standards in India ("Ind AS") notified under the companies (Indian Accounting Standards) Rules, 2015 (as amended from time to time) This note provides a list of the significant accounting policies adopted in the preparation of the Financial Statements comprising of Balance Sheet, Statement of Profit and Loss including Other Comprehensive Income and notes to accounts.

Accounting policies have been consistently applied except where a newly issued accounting standard is initially adopted or a revision to an existing accounting standard requires a change in the accounting policy hitherto in use.

b. Cash Flow Statement (Ind AS - 7)

Cash Flows are reported using the indirect method whereby the net profit before tax is adjusted for the effects of transactions of non-cash nature and deferrals or accruals of the past or future cash receipts or payments. The cash flows from regular revenue generating, investing & financing activities of the company are segregated.

c. Cash & Cash Equivalents

Cash and cash equivalents comprise cash and cash on deposit with banks. The Company considers all highly liquid investments with maturity of three months or less and that are readily convertible to known amounts of cash to be cash equivalents.

d. Accounting Policies, Changes in Accounting Estimates and Errors (Ind AS - 8)

The preparation of financial statements in conformity with "Ind AS" requires the management of the Company to make estimates and assumptions that affect the reported balances of assets and liabilities and disclosures relating to the contingent liabilities as at the date of the financial statements and reported amounts of income and expense during the year. Examples of such estimates include provisions for doubtful receivables, provision for income taxes, the useful lives of depreciable fixed assets both tangible and intangible assets and provision for impairment, valuation of inventories, assessment of recoverable amounts of deferred tax assets, provision for sales returns, provision for obligations relating to employees, provisions against litigations and contingencies. Estimates and underlying assumptions are reviewed on an ongoing basis. Actual results could differ due to changes in these estimates and the difference between the actual result and the estimates are recognized in the period in which the results are known / materialize.

Judgements:

Financial Statements are made with information about judgements made in applying accounting policies that have a most significant effect on the amount recognized in the Financial Statements.



Assumptions and estimation uncertainties:

Financial Statements are made with information about assumptions and estimation uncertainties that have a significant risk of resulting in a material adjustment in the year ended 31st March 2023.

e. Property, Plant & Equipment

Property, Plant & Equipment (Ind AS - 16)

Fixed Assets are stated at cost of acquisition net of recoverable taxes less accumulated depreciation and impairment loss, if any. Cost includes direct expenses as well as clearly identifiable indirect expenses incurred to bring the assets to their working condition for its intended use. Subsequent expenditures related to an item of tangible asset are added to its book value only if they increase the future benefits from the existing asset beyond its previously assessed standard of performance.

Intangible Assets (Ind AS - 38)

Intangible Assets are stated at cost of acquisition net of recoverable taxes less accumulated amortisation/ depletion and impairment loss, if any. The cost comprises purchase price, borrowing costs, and any cost directly attributable to bringing the asset to its working condition for the intended use attributable to the intangible assets.

Accounting Of Lease (IND AS 116)

Company has identified the Lease arrangements which are to be classified as Right to Use. Short Term Lease Arrangements are not considered under this standard.

As a result, Lease agreements having long term tenure are identified for IND AS 116 purpose and accordingly accounting treatment is being given.

Right to Use is created as Non-financial Asset at present value for all future Rental Payments.

Lease Liability is created for the amount equivalent to Right to Use.

Right to Use is amortised over the period of lease term and is charged to Profit and loss.

Interest is calculated on Lease Liability and same is charged to Profit and Loss as Finance Cost.

f. Depreciation and Amortization (Ind AS - 16)

Depreciation on Property, Plant & Equipment is provided on the 'Straight Line Method' as per schedule II of the Companies Act, 2013. Depreciation for assets purchased / sold during a period is proportionately charged. Individual low-cost assets (acquired for ₹. 5,000/- or less) are depreciated over a period of one year from the date of acquisition.

The residual value of Property, Plant & Equipment where the estimated useful life as prescribed in the Schedule II of the Companies Act, 2013 was completed, the depreciation charged on such Property,

Intangibles

Intangible assets are amortized over their respective individual estimated useful lives on a straight-line basis, commencing from the date the asset is available to the Company for its use.

Depreciation and amortization methods, useful lives and residual values are reviewed at each reporting date.



Intangibles under Development

Intangible assets which are not put to use but are under development stage, will be accounted as Intangibles under Development.

g. Revenue from Contracts with Customers (Ind AS - 115)

i. Revenue from Operation

Management fee is recognized at specific rates agreed with the relevant schemes, applied on daily net assets of each scheme, and is in conformity with the regulatory guidelines. Commission income from POP Business i.e Account opening fees and Contribution processing fees are recognised on the basis of contributions received from subscribers and generation of PRAN. The Company presents revenues net of Goods and Service Tax in its Statement of Profit and Loss.

ii. Other Income

Revenue is recognized only when it is reasonably certain that the ultimate collection will be made. Interest on Fixed Deposits is recognized on accrual basis. Other income is recognized as and when it is received.

h. Investment Property (Ind AS - 40)

Trade investments are the investments made to enhance the Company's business interests. Investments are either classified as current or long term based on Management's intention. Current investments are carried at the lower of cost and fair value of each investment individually. Long term investments are carried at cost less provisions recorded to recognize any decline, other than temporary, in the carrying value of each investment.

i. Retirement Benefits (Ind AS - 19)

a. Provident fund is a defined contribution scheme and the contributions for market recruits as required by the statute paid to Government Provident Fund are charged to profit and loss account. However, it also includes payment of provident fund of employees on deputation from State Bank of India, paid by state Bank of India, however same is reimbursed by the Company.

b. Liabilities on account of the provision of Gratuity, of officer on deputation from State Bank of India are made by State Bank of India, however same is reimbursed by the Company. Gratuity for Market recruits is covered by gratuity policy obtained.

c. Salary, allowances and other perquisites paid to the officers on deputation from State Bank of India (SBI) are reimbursed to SBI on actual basis. Additionally, 30% of officers' salary towards Bank's contribution to SBI Employees' Provident Fund, SBI Employees' Pension Fund and Employees' Gratuity Fund are also reimbursed to SBI.

j. Earnings per share (Ind AS - 33)

Basic earnings per share are computed by dividing the net profit after tax by the weighted average number of equity shares outstanding during the period. Diluted earnings per share is computed by dividing the net profit after tax by the weighted average number of equity shares considered for deriving basic earnings per share and also the weighted average number of equity shares that could have been issued upon conversion of all dilutive potential equity shares. The diluted potential equity shares are adjusted for the proceeds receivable, had the shares been actually issued at fair value, which is the average market value of the outstanding shares. Dilutive potential equity shares are deemed converted as of the beginning of the period, unless issued at a later date. The number of shares and potentially dilutive equity shares are adjusted retrospectively for all periods presented for any share splits and bonus shares issues including for changes effected prior to the approval of the financial statements by the Board of Directors.



k Income Taxes (Ind AS - 12)

Income tax is accrued in the same period that the related revenue and expenses arise. A provision is made for income tax annually, based on the tax liability computed, after considering tax allowances and exemptions. Provisions are recorded when it is estimated that a liability due to disallowances or other matters is probable. Minimum Alternate Tax (MAT) paid in accordance with the tax laws, which gives rise to future economic benefits in the form of tax credit against future income tax liability, is recognized as an asset in the Balance Sheet if there is convincing evidence that the Company will pay normal tax after the tax holiday period and the resultant asset can be measured reliably. The Company offsets, on a year on year basis, the current tax assets and liabilities, where it has a legally enforceable right and where it intends to settle such assets and liabilities on a net basis.

The differences that result between the profit considered for income taxes and the profit as per the financial statements are identified, and thereafter a deferred tax asset or deferred tax liability is recorded for timing differences, namely the differences that originate in one accounting period and reverse in another, based on the tax effect of the aggregate amount of timing difference. The tax effect is calculated on the accumulated timing differences at the end of an accounting period based on enacted or substantively enacted regulations. Deferred tax assets in situations where unabsorbed depreciation and carry forward business loss exists, are recognized only if there is virtual certainty supported by convincing evidence that sufficient future taxable income will be available against which such deferred tax asset can be realized. Deferred tax assets, other than in situations of unabsorbed depreciation and carry forward business loss, are recognized only if there is reasonable certainty that they will be realized.

Deferred tax assets are reviewed for the appropriateness of their respective carrying values at each reporting date. Deferred tax assets and deferred tax liabilities have been offset wherever the Company has a legally enforceable right to set off current tax assets against current tax liabilities and where the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority.

I. Impairment of Assets (Ind AS - 36)

The Management periodically assesses using, external and internal sources, whether there is an indication that an asset may be impaired. An impairment loss is recognized wherever the carrying value of an asset exceeds its recoverable amount. The recoverable amount is higher of the asset's net selling price and value in use, which means the present value of future cash flows expected to arise from the continuing use of the asset and its eventual disposal.

An impairment loss for an asset is reversed if, and only if, the reversal can be related objectively to an event occurring after the impairment loss was recognized. The carrying amount of an asset is increased to its revised recoverable amount, provided that this amount does not exceed the carrying amount that would have been determined (net of any accumulated amortization or depreciation) had no impairment loss been recognized for the asset in prior years.

m. Provisions, Contingent Liabilities and Contingent Assets (Ind AS - 37)

AA provision is recognized when the Company has a present obligation as a result of a past event; it is probable that an outflow of resources will be required to settle the obligation, in respect of which a reliable estimate can be made. Provisions are not discounted to its present value and are determined based on best estimate required to settle the obligation at the balance sheet date. These are reviewed at each balance sheet date and adjusted to reflect the current best estimates Contingent Liabilities, if any, are disclosed in the Notes to Accounts. Provision is made in the accounts in respect of those contingencies which are likely to materialize into liabilities.



A provision is recognized if, as a result of a past event, the Company has a present legal obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. Provisions are determined by the best estimate of the outflow of economic benefits required to settle the obligation at the reporting date. Where no reliable estimate can be made, a disclosure is made as contingent liability. A disclosure for a contingent liability is also made when there is a possible obligation or a present obligation that may, but probably will not, require an outflow of resources. Where there is a possible obligation or a present obligation in respect of which the likelihood of outflow of resources is remote, no provision or disclosure is made.

n. Financial Instruments

Financial assets and financial liabilities are recognised in the Balance Sheet on trade date when the Company becomes a party to the contractual provisions of the instrument.

Recognised financial assets and financial liabilities are initially measured at fair value. Transaction costs and revenues that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at FVTPL) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs and revenues directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in the Statement of Profit and Loss.

If the transaction price differs from fair value at initial recognition, the Company will account for such difference as follows:

a) If fair value is evidenced by a quoted price in an active market for an identical asset or liability or based on a valuation technique that uses only data from observable markets, then the difference is recognised in the Statement of Profit and Loss on initial recognition (i.e. day 1 profit or loss);

b) In all other cases, the fair value will be adjusted to bring it in line with the transaction price (i.e. day 1 profit or loss will be deferred by including it in the initial carrying amount of the asset or liability).

After initial recognition, the deferred gain or loss will be released to the Statement of Profit and Loss on a rational basis, only to the extent that it arises from a change in a factor (including time) that market participants would take into account when pricing the asset or liability.

o. Financial assets

Classification

On initial recognition, depending on the Company's business model for managing the financial assets and its contractual cash flow characteristics, a financial asset is classified as measured at;

- 1) Amortised cost;
- 2) Fair value through other comprehensive income (FVTOCI); or
- 3) Fair value through profit and loss (FVTPL).

Initial recognition and measurement

Financial asset is recognised on trade date initially at cost of acquisition net of transaction cost and income that is attributable to the acquisition of the financial asset. Cost equates the fair value on acquisition. Financial asset measured at amortised cost and financial asset measured at fair value through other comprehensive income are presented at gross carrying value in the Financial Statements. Unamortised transaction cost and unamortised income and impairment allowance on financial asset are shown separately under the heading "Other non-financial asset", "Other non-financial liability" and "Provisions" respectively.



Based on the assessment of the business models, the Company has identified the following three choices of classification of its financial assets:

a) Financial assets that are held within a business model whose objective is to collect the contractual cash flows ("Asset held to collect contractual cash-flows"), and that have contractual cash flows that are solely payments of principal and interest on the principal amount outstanding (SPPI), are measured at amortised cost;

b) Financial assets that are held within a business model whose objective is both to collect the contractual cash flows and to sell the assets, ("Contractual cash flows of Asset collected through hold and sell model") and that have contractual cash flows that are SPPI, are measured at FVTOCI.

c) All other financial assets (e.g. managed on a fair value basis, or held for sale) and equity investments are measured at FVTPL.

Financial asset at amortised cost:

Amortised cost of financial asset is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. For the purpose of SPPI test, principal is the fair value of the financial asset at initial recognition. That principal amount may change over the life of the financial asset (e.g. if there are repayments of principal). Contractual cash flows that do not introduce exposure to risks or volatility in the contractual cash flows on account of changes such as equity prices or commodity prices and are related to a basic lending arrangement, do give rise to SPPI. An originated or an acquired financial asset can be a basic lending arrangement irrespective of whether it is a loan in its legal form.

The EIR amortisation is included in finance income in the Statement of Profit and Loss. The losses arising from impairment are recognised in the Statement of Profit and Loss.

Financial asset at fair value through Other Comprehensive Income (FVTOCI)

After initial measurement, basis assessment of the business model as "Contractual cash flows of Asset collected through hold and sell model and SPPI", such financial assets are classified to be measured at FVTOCI. Contractual cash flows that do introduce exposure to risks or volatility in the contractual cash flows due to changes such as equity prices or commodity prices and are unrelated to a basic lending arrangement, do not give rise to SPPI.

The EIR amortisation is included in finance income in the Statement of Profit and Loss. The losses arising from impairment are recognised in the Statement of Profit and Loss. The carrying value of the financial asset is fair valued by discounting the contractual cash flows over contractual tenure, basis the internal rate of return of a new similar asset originated in the month of reporting and such unrealised gain/loss is recorded in Other Comprehensive Income (OCI). Where such a similar product is not originated in the month of reporting, the closest product origination is used as a proxy. Upon sale of the financial asset, actual the gain/loss realised is recorded in the Statement of Profit and Loss and the unrealised/gain losses recorded in OCI are recycled to the Statement of Profit and Loss.

Financial asset at fair value through profit and loss (FVTPL)

Financial asset, which does not meet the criteria for categorization at amortised cost or FVTOCI, is classified as at FVTPL. In addition, the Company may elect to classify a financial asset which otherwise meets the amortised cost or FVTOCI criteria as FVTPL. However, such election is allowed only if doing so reduces or eliminates a measurement or recognition inconsistency (referred to as 'accounting mismatch'). Financial assets included within the FVTPL category are measured at fair value with all changes recognised in the Statement of Profit and Loss.



Reclassifications within classes of financial assets

A change in the business model would lead to a prospective re-classification of the financial asset and accordingly, the measurement principles applicable to the new classification will be applied. During the current financial and previous accounting years, there was no change in the business model under which the Company held financial assets and therefore, no reclassifications were made.

Modification and De-recognition of financial assets

Modification of financial assets

A modification of a financial asset occurs when the contractual terms governing the cash flows of a financial asset are renegotiated or otherwise modified between initial recognition and maturity of the financial asset. A modification affects the amount and/or timing of the contractual cash flows either immediately or at a future date. The Company renegotiates loans to customers in financial difficulty to maximise collection and minimise the risk of default. A loan forbearance is granted in cases where although the borrower made all reasonable efforts to pay under the original contractual terms, there is a high risk of default or default has already happened and the borrower is expected to be able to meet the revised terms. The revised terms in most of the cases include an extension of the maturity of the loan, changes to the timing of the cash flows of the loan (principal and interest repayment), reduction in the amount of cash flows due (principal and interest forgiveness). Such accounts are classified as stage 3 immediately upon such modification in the terms of the contract.

Not all changes in terms of loans are considered as renegotiation and changes in terms of a class of obligors that are not overdue is not considered as renegotiation and is not subjected to deterioration in staging.

De-recognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a Company of similar financial assets) is derecognised when:

1) the rights to receive cash flows from the asset have expired, or

2) the Company has transferred its rights to receive cash flows from the asset and substantially all the risks and rewards of the asset, or the Company has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset

If the Company retains substantially all the risks and rewards of ownership of a transferred financial asset, the Company continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

Financial liability, Equity and Compound Financial Instruments

Financial liabilities

A financial liability is a contractual obligation to deliver cash or another financial asset or to exchange financial assets or financial liabilities with another entity under conditions that are potentially unfavourable to the Company or a contract that will or may be settled in the Company's own equity instruments and is a non-derivative contract for which the Company is or may be obliged to deliver a variable number of its own equity instruments, or a derivative contract over own equity that will or may be settled other than by the exchange of a fixed amount of cash (or another financial asset) for a fixed number of the Company's own equity instruments.



Classification

The Company classifies its financial liability as "Financial liability measured at amortised cost" except for those classified as financial liabilities measured at fair value through profit and loss (FVTPL).

Initial recognition and measurement

Financial liability is recognised initially at cost of acquisition net of transaction costs and incomes that is attributable to the acquisition of the financial liability. Cost equates the fair value on acquisition. The Company may irrevocably designate a financial liability that meet the amortised cost as measured at FVTPL if doing so eliminates or significantly reduces an accounting mismatch (referred to as the fair value option).

De-recognition of financial liabilities

The Company derecognises financial liabilities when and only when the Company's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in the Statement of Profit and Loss.

<u>Equity</u>

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recognised at the proceeds received, net of direct issue costs. A conversion option that will be settled by the exchange of a fixed amount of cash or another financial asset for a fixed number of the Company's own equity instruments is an equity instrument.

No gain/loss is recognised in the Statement of Profit and Loss on the purchase, sale, issue or cancellation of the Company's own equity instruments.

p. Segment Reporting

Identification of Segments Operating

Segments are identified based on monitoring of operating results by the chief operating decision maker (CODM) separately for the purpose of making decision about resource allocation and performance assessment. Segment performance is evaluated based on profit or loss and is measured consistently with profit or loss of the Company.

Operating Segment is identified based on the nature of products and services, the different risks and returns, and the internal business reporting system.

Segment Policies

The Company prepares its segment information in conformity with the accounting policies adopted for preparing and presenting the financial statements of the Company as a whole. Further, inter-segment revenue has been accounted for based on the transaction price agreed to between segments, which is primarily market based. Unallocated Corporate Items include general corporate income and expenses, which are not attributable to segments
